## Higher Education Emergency Relief Fund Report Emergency Financial Aid Grants to Students

October 9, 2020

InterCoast Colleges (OPE ID 025594) received education stabilization funds under Section 18004(a)(1) of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"), Public Law No: 116-136. This Fund Report applies to the student portion received under the Higher Education Emergency Relief Fund that is designated exclusively for emergency financial aid grants to students.

The institution appreciates that Congress and the President have made these critical funds available for eligible students who have expenses related to the disruption of campus operations due to the coronavirus pandemic. We take receipt of these federal funds seriously and are distributing them in accordance with the CARES Act and implementing guidance.

1. The institution signed and returned to the Department the Certification and Agreement [for] Emergency Financial Aid Grants to Students. The institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004(a)(1) of the CARES Act to provide emergency financial aid grants to students.
2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement [for] Emergency Financial Aid Grants to Students \$1,079,000.00.
3. The total amount of emergency financial aid grants distributed to students under Section 18004(a)(1) of the CARES Act as of the date of this Fund Report is \$ 550,000.00.

## Attachment A

### **InterCoast College's Policy of Determining Which Students Would Receive Emergency HEERF Grant Funds**

#### Selection of Students

InterCoast Colleges has identified approximately 696 students as potential eligible students. InterCoast's student selection is based those that attended during a payment period effected by COVID-19.

#### Eligibility for Emergency Grant Funds

Federal regulations require any student that receives a CARES Act Higher Education Emergency Relief Grant must meet the same eligibility criteria to be eligible for Title IV financial aid as defined under Section 484 of the Higher Education Act (HEA), including but not limited to the following:

- US Citizen or an eligible noncitizen
- Valid Social Security number
- Male students must be registered with Selective Service
- Not in default on a federal student loan or in a grant overpayment
- Must be making Satisfactory Academic Progress.
- Other criteria as outlined in Section 484 of the HEA.

Only students that have completed the Application for Emergency Grant and are eligible for Title IV financial aid will be deemed as eligible for this Emergency Grant. In addition, the student will be required to submit a completed Application for Emergency Grant that will include an attestation that the student had expenses incurred related to the disruption of campus operations due to COVID-19.

#### Distributed Awards

An award of \$1500.00 will be given to students who meet the eligibility criteria.

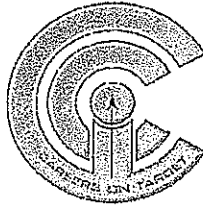

Dear Student,

Like other students everywhere, we know that many of our on-ground students are facing unexpected financial hardships and other personal challenges due to the COVID 19 crisis. Despite these difficult times, you have persisted in your education and career goals. We also thank you for your patience and flexibility during our transition to 100% online classes on a temporary basis. Your perseverance and resilience are admirable, and all of us here at InterCoast Colleges are very proud of your progress in school.

The federal CARES Act has provided colleges and universities with some stimulus funds. InterCoast Colleges will be providing emergency CARES grants to eligible students in good standing who are enrolled during a payment period effected by COVID-19.
